


## Posters

## MPA's Position

Government announced changes to social distancing guidance last week, with relaxation of the 2m rule where other mitigation is possible, and lengthy guidance for pubs, restaurants and other businesses that will be allowed to re-open on 4 July. A reminder of the position from MPA's health and safety team:

It will be for members to decide whether they choose to modify their working practices. However for the moment, the MPA advice on social distancing will not change. Social distancing is a primary control measure and the scientific information tells us that the risk of virus transmission is significantly reduced as separation/distancing increases. Therefore, we do not propose to amend the guidance and recommend that members should continue to work to the 2m standard wherever possible. As before, if it is not possible to work to 2m separation, other control measures should be applied to reduce the risk. We will of course, continue to monitor the scientific information/advice and will review and update our guidance when supported by the evidence.
